COURSE METHODOLOGY: The Course will be conducted by CCEK through its sub-Centre's in linkage with NSDC Training Partner as the Nodal Facilitation Support Partner for implementing the activities necessary for imparting vocational training to the students. The entire duties and responsibilities of imparting vocational training to students in connection with the conduct of the skill development programs through its sub-Centre's all over Kerala will be done by the three stake holders mentioned below:

- (1) Centre for Continuing Education Kerala (CCEK),
- (2) Sub-Centre's of CCEK
- (3) NSDC Training Partner

AND WHEREAS NSDC Training Partner has consented to associate with CCEK as the Nodal Facilitation Support Partner as per mutually agreed terms and conditions. Centre for Continuing Education Kerala (CCEK), its Sub-Centre

1. The roles and responsibilities of each of the three parties in the conduct of the course will be governed as in **ANNEXURE I** attached to this MoU.
2. The conditions on eligibility for admission to the course, duration of the course, course fee and the mandatory reservation policy will be as per the conditions approved vide GO(Rt.) No. 3229/2016/H.Edn. Dated 25/11/2016.
3. A minimum intake of 25 students per batch in each sub-centre is expected for the course.
4. The sub-centres can commence the course with the support of NSDC Training Partner on executing this MoU and the minimum number of students is admitted to the course.
5. The Syllabi for the Skill Development Programs will be as prescribed by CCEK/NSDC.
6. Rules and Regulations for the examination and promotion of students for the course will be governed as prescribed in **ANNEXURE II** attached to this MoU.
7. The Financial Arrangements between the parties will be governed as per the conditions approved vide GO (Rt.) No. 3229/2016/H.Edn. Dated 25/11/2016.


9. The due share of the fee collected from students should be remitted to the accounts of both CCEK and NSDC Training Partner on time through DD or Electronic Transfer by the CCEK Sub Center as per the revenue sharing pattern mentioned above.
10. The revenue sharing ratio for Govt. projects shall be depended on mutually agreed terms and conditions between CCEK, CCEK Sub Center & NSDC Training Partner.
11. The following arrangements will also be operative between the CCEK, Sub- centres and NSDC Training Partner:
 - 11.1 In the event of any financial loss suffered by *any of the three parties* on account of the implementation of the project, the financial liability will be limited to extent of the rates agreed at the financial arrangements of this MoU.
 - 11.2 CCEK or the sub-centre will not be responsible for any loan/liability availed by NSDC Training Partner for executing this project.
 - 11.3 CCEK will not be responsible for any violation or infringement of copyright act or usage of any unauthorized software by NSDC Training Partner for implementation of the project.
 - 11.4 CCEK shall have the right to modify the curriculum, semester planning, academic scheduling and all other necessary proceedings regarding the conduct of courses, if it deems fit. Any changes if so made will be communicated to NSDC Training Partner.
 - 11.5 CCEK shall have the right to nominate and depute a competent person/ subject expert to verify and scrutinize the proper conduct of the course and the NSDC Training Partner shall provide ample opportunity for the person so deputed to carry out the assignment.

- 11.6 NSDC Training Partner shall be bound to furnish and provide all the necessary information sought by CCEK to enable the smooth conduct of the courses.
- 11.7 The NSDC Training Partner shall ensure that quality training is provided to all the beneficiaries and their responsibilities as envisaged in this MoU are fulfilled during the course of validity of the MoU.
- 11.8 Any necessary directions and suggestions given by CCEK from time to time for the successful conduct of the courses shall be strictly adhered by NSDC Training Partner and Sub-Centre's and any reports sought for regarding any matter shall be given in due time by NSDC Training Partner and Sub-Centre's.
- 11.9 CCEK and NSDC Training Partner shall obtain prior written consent from the other parties for the use of its name in any matter other than specifically mentioned in this MoU.
- 11.10 In case the course is offered at the premises arranged by NSDC Training Partner as agreed by the Sub-Centre, NSDC Training Partner shall place a name board as per the specifications prescribed by CCEK mentioning the premises as the NSDC-CCEK Skill Development Resource Centre.
12. **GST:** In any case the programme falls in the ambit of GST, the tax amount shall be collected from the students over and above the course fee as per the directions from Central Excise and the respective amount of GST should be paid by each and every stake holder according to their proportionate share of revenue.

a. The Project Coordinator, CCEK and the Academic Expert member will be nominated by the Director, CCEK and the Project Coordinator, NSDC Training Partner will be nominated by the Managing Director, NSDC Training Partner whose main responsibility will be to execute and coordinate all activities mentioned in the MoU.

b. The Project Evaluation Committee shall meet at least on a quarterly basis and review the progress of the project and take remedial action if found necessary.

14. Any change in the terms and conditions of this MoU should be effected only through mutual agreement of both the parties as decided by the Project Evaluation Committee and shall be shall be made in writing and executed by both CCEK and NSDC Training Partner.

15. **SETTLEMENT OF DISPUTES:** In case of any dispute/difference of opinions in respect of any of the above clauses including its interpretation thereof, the matter will be submitted for a decision of a committee comprising of the Director, CCEK and the Managing Director, NSDC Training Partner. The decision of the Committee on any or all of the matters thereof shall be final and binding on both the parties. But if the dispute is not settled within 30 days, the dispute can be referred to Government for settlement and if not settled be referred to arbitration and conciliation as per the Arbitration & Conciliation Act 1996. All disputes /legal issues arising of this MoU or with regard to the clauses in this MoU shall be determined/adjudicated by the courts having jurisdiction in Thiruvananthapuram only.

16. **VALIDITY OF THE MoU:** The validity of MoU shall be effective for a **Period of 01 (One) Year** from the date of Execution.

17. However it shall be within the rights of all parties to cancel this MoU for the reason proved violation of any of the clauses of this agreement after giving due notice of such violation. All notices shall be served on the addresses of the parties by respective parties 03 calendar months in advance. However, such cancellation shall be given effect to only after all the three parties mutually ensure that all steps have been taken to protect the interests of all the three parties up to the date of cancellation and also the interests of the students admitted to the courses.



CENTRE FOR CONTINUING EDUCATION KERALA ROLES AND RESPONSIBILITIES OF CCEK, SUB-CENTRES AND THE NSDC TRAINING PARTNER IN CONDUCTING COURSES

A. ROLES AND RESPONSIBILITIES OF CCEK

- 1.1 CCEK will ensure the uniformity of the course in all its sub-centres regarding
 - i. Syllabus
 - ii. Course fee
 - iii. Duration
 - iv. Exam pattern
 - v. Certification
- 2.0 CCEK will decide the sub-centres in which the course is to be conducted and inform the same to the NSDC Training Partner with which the linkage is established.
- 3.0 CCEK will send programme guidelines to the identified sub-centres for offering the course, as and when found necessary.
- 4.0 CCEK will arrange to do press releases for publicity about the course, after identifying the sub-centres in which the course is to be offered.
- 5.0 CCEK will arrange to print application forms and make it available to students in all sub-centers free of cost and also make it available for downloading from the websites of CCEK.
- 6.0 CCEK will arrange to provide Call Centre Facility to answer all the queries regarding the course.
- 7.0 CCEK will arrange to print identity card, fee card, etc. For the course and issue the same to the candidates registered for the course at the respective sub-centres.
- 8.0 CCEK will arrange to evaluate the feedback and the reports regarding the course, from the students and sub-centres and suggest corrective measures to NSDC Training Partner or Sub-Centres wherever necessary.

- 9.0 CCEK will arrange to allot a Unique Register Number to all the students admitted to the course.
- 10.0 CCEK will arrange the required staff for monitoring the quality and coordination activities for the conduct of the course, which includes state coordinator, district coordinators, call centre executives, data entry operators etc.,
- 11.0 CCEK will arrange to develop and maintain a Student's Performance Evaluation System for ensuring proper monitoring of quality of the programme with the required data received from NSDC Training Partner and sub-centres.
- 12.0 CCEK will arrange to prepare, update and upload a question bank for the guidance of the students for getting prepared for the examination.
- 13.0 CCEK will arrange to conduct examinations in the sub-centres at regular time period, which include the following:
- Conduct Online Examination
 - Sending results to various sub center authorities.
 - Printing and distribution of certificates to the successful students (*through the sub centers within 30 days of publishing results of the examination*).
- 14.0 There will be a Board of Examination under CCEK with a Controller of Examination, a Joint Controller of Examination and a Convener. The Director, CCEK will be the Appellate Authority in case any dispute arises with regard to the examination.
- 15.0 CCEK will arrange to develop a Web Portal for the smooth conduct of Continuing Education Programmes with provisions for information regarding the Training Programme, On-line Monitoring, Examination, Placement Assistance, Students Grievance Redressal etc

B. ROLES AND RESPONSIBILITIES OF SUB-CENTRES

- 1.0 The sub-centre will provide press release/ Class Room Circulars /Notifications for Admission as per the guidelines of CCEK.
- 2.0 The sub-centre will issue / distribute the application forms for the programme supplied by CCEK.
- 3.0 The sub-centre will provide the necessary support for the conduct of the course in accordance with the guidelines of CCEK.
- 4.0 The sub-centre will maintain proper records of the students admitted to the course and for the collection of fee in accordance with the guidelines issued by CCEK and be made available to CCEK and NSDC Training Partner as and when requested.
- 5.0 The sub-centre will prepare a consolidated report on the applications with eligibility/community certificate collected and forward to CCEK as and when required.
- 6.0 The sub-centre will ensure that the candidates selected for the course possess the required minimum qualification prescribed. The sub-centre will admit the students as per the criteria prescribed by CCEK.

7.0 The sub-centre will collect the fee amount and forward the proportionate amount of fee, after retaining their share as fixed at the Financial Arrangements approved by Government, to CCEK and NSDC Training Partner by a Cheque/Demand Draft on or before the 10th working day of every month based on the fee collected as on last working day of the previous month.

8.0 The sub-centre has the discretion to collect the fee in installments. *Proper care should be taken to avoid any loss on account of this.*

9.1 The sub-centre shall maintain all proper records about the course programme which includes:

- a. Students Register (format specified by CCEK)
- b. Application forms
- c. Photo of each student
- d. Attested copy of eligibility certificate (*proof of qualification & Date of Birth*)
- e. Community certificate (if necessary for reservation)
- f. Attested copies of Ration Card (if necessary for BPL reservation)
- g. Attendance Registers (in liaison with NSDC Training Partner)
- h. Fee Registers (format specified by CCEK)

C. ROLES AND RESPONSIBILITIES OF THE NSDC TRAINING PARTNER

1.0 The NSDC Training Partner concerned shall be the Nodal Facilitation Support Partner for the conduct of the identified courses of CCEK/NSDC.

2.0 The NSDC Training Partner concerned shall commence the course at the sub- centre after getting confirmation from CCEK.

- 3.0 The front end promotion of the linkage programme shall be done by the NSDC Training Partner with the consent of the sub-centre.
- 4.0 The NSDC Training Partner shall provide necessary support such as counseling and supporting materials for the promotion of the course with the consent of sub-centre.
- 5.0 The NSDC Training Partner shall make necessary advertisements for the course.
- 6.0 The NSDC Training Partner shall provide all the necessary support for the delivery of the course to the students admitted in accordance with the guidelines issued by CCEK and keeping the quality of the training.
- 7.0 The NSDC Training Partner shall provide the medium of instruction in all the theory and practical subjects of training in English & Malayalam.
- 8.0 The NSDC Training Partner shall arrange the required number of qualified and competent teaching faculty in each sub-centre for the conduct of the course according to the guidelines issued by CCEK. Those found competent by the Resource Screening Committee alone will be allowed to handle the classes in the sub-centres.
- 9.0 The NSDC Training Partner shall also ensure that state-of art facility is provided for the implementation of the course wherever necessary.
- 10.0 The NSDC Training Partner shall make necessary arrangements for providing alternate arrangements for the classes in case the faculty responsible happens to be on leave on a particular day.

ANNEXURE II

CENTRE FOR CONTINUING EDUCATION KERALA RULES AND REGULATIONS FOR EXAMINATION AND PROMOTION FOR THE COURSES

- 1) The duration of the course is as mentioned in the prospectus.
- 2) The minimum qualification prescribed for admission is SSLC.
- 3) There will be an examination for theory (Online) and practical subjects as per the notification issued by CCEK from time to time. The examinations will be conducted by CCEK.
- 4) Minimum attendance required for a candidate to register for the examination is 70%.
- 5) Shortage of attendance up to 15% can be condoned in deserving cases on payment of prescribed condensation fee of Rs.200/- on the recommendation of the sub-Centre. *Condonation fee from the students will be collected by the sub-Centre concerned and forwarded to the Director, CCEK by DD payable at Thiruvananthapuram in lump sum with the details of the candidates registered for the examination.*
- 6) The details regarding registration for the examination and fee to be remitted will be published in the examination notification.
- 7) No candidate will be allowed to register for examination in piecemeal. If in any case this happens, registration shall automatically be cancelled at any stage of the process of the examination. The Board of Examination has the discretionary power to relax the condition in exceptional cases, if found necessary.
- 8) Each candidate is entitled for three chances to pass the examination, including the regular within a period of 2 Years after the registration for the first examination. The Board of Examination has the discretionary power to relax the condition in exceptional cases, if found necessary.

INTRODUCTION

ELIGIBILITY/TARGET GROUP

Background

WHEREAS, KSEB Ltd as part of implementing Grid Connected Roof Top Solar Photo Voltaic Power Projects (Soua
Project) had invited registrations from interested consumers of KSEB Ltd to establish Roof top Solar PV Plant / to lend
Roof Top , for the aforesaid project

AND WHEREAS the Consumer had registered and expressed his/her/their willingness to establish the same.
Accordingly, KSEB Ltd has conducted feasibility study at the premises of the Consumer and proposes to implement a
..... 34..... kWp Grid connected Roof Top Solar Photo Voltaic Power Project, subject to other constraints,
if any.

NOW THESE PRESENTS WITNESS, it is hereby MUTUALLY AGREED BY AND BETWEEN THE PARTIES HERETO as follows:

1. Obligation of KSEB Ltd

a. KSEB Ltd / Solar Power Developer engaged by KSEB Ltd shall use the said rooftop for the purpose of Solar Power Project and will not in any way utilize the rooftop except for the said purpose.

b. The design, engineering, procurement, installation, testing and commissioning of the solar plant shall be done by KSEB Ltd / Solar Power Developer engaged by KSEB Ltd, at their cost. The ownership of the said plant will vest with KSEB Ltd/ Solar Power Developer engaged by KSEB Ltd, during the currency of this agreement period.

c. KSEB Ltd/its authorised person shall carry out the operation and routine maintenance of the plant for 25 years, from the date of commissioning of the plant.

d. KSEB Ltd/ its authorised person shall undertake repair/rectification of the plant upon malfunctioning / non-generation of energy.

e. KSEB Ltd / Solar Power Developer engaged by KSEB Ltd shall make only minimum alterations/ modifications in the premises, as is required for establishing the Photo Voltaic panels in the optimal angle and for routing of cables and for installing associated hardware.

f. KSEB Ltd shall ensure grid connectivity to the power generated in the plant, but without provision for any storage or backup of power.

g. Statutory permits/ approvals related to energisation and grid connectivity of the plant shall be obtained by KSEB Ltd / Solar Power Developer engaged by KSEB Ltd.

2. Scope of the Consumer

a. The consumer shall provide shade free area of 4000 sq.ft on the roof top of the building to KSEB Ltd / Solar Power Developer authorised by KSEB Ltd during the construction period and 25 years from date of Commercial Operation of the plant or mutually agreed extended period as required for the purpose of installing solar plant with capacity of 34 kWp, and for operation and maintenance of the plant to be carried out either by KSEB Ltd or its authorized representative, during the tenure of the agreement period. He/She shall remove the trees/branches etc. in order to maintain the area completely shadow free.

The details of building is as scheduled below.

b. The Consumer shall also provide access to the premises/rooftop to KSEB Ltd or its authorized person for transportation of the materials for installation, operation, maintenance and other allied activities of the plant during the agreement period.

c. The security and safety of the plant shall be the responsibility of the consumer, except under force majeure conditions.

d. The area for installation of the solar plant shall be clearly demarcated prior to commencement of the work and such area shall be free from any installations/ structures that hinder set up and upkeep of the power plant.

e. The consumer shall provide facility for accommodating the accessories of solar plant such as inverter, solar meter, net meter etc.

f. The consumer shall provide space for routing the cable between solar plant and inverter and between inverter and metering point.

g. Modifications related to the existing consumer side wiring installation if any, for incorporation of the solar power shall be the responsibility of the consumer.

h. The consumer is not at liberty to get the plant repaired/ replaced through a third party.

i. If the building/ premises is rented/leased out, recitals of this agreement shall be made part of the rent/lease agreement so as to facilitate the implementation/ other allied works connected with the plant.

j. The consumer shall provide basic amenities for installation of the plant. He/ She shall also provide water for cleaning the plant during the maintenance.

k. The consumer shall provide site for temporary stacking of the materials prior to installation of the plant.

l. The consumer is not authorised to make any alteration in the circuit of the said plant or loop/tap power directly from the plant by any means.

3. Duration of the Agreement

This agreement shall commence from the date of handing over of the Roof Top/Premises to KSEB Ltd for the installation of the solar plant. This Agreement shall continue to be in force for a period of 25 years from the date of commissioning of the plant, unless the agreement is terminated as per clause 10 of this agreement. This Agreement may be extended for a further period on mutually agreed terms and conditions.

4. Applicable Laws/ Regulations

The parties have understood and agreed to abide by the relevant provisions of Electricity Act 2003 and applicable regulations and all amendments made therein from time to time. All relevant regulation in regard to the supply of electricity shall form part of this Agreement.

5. Metering

There shall be two type of energy meters installed in the system.

1. Solar meter. The solar meter records the total AC energy output of the solar plant.

2. Net Meter. Net meter records the energy injected into the grid (export) and energy drawn from the grid (import) and the net energy. Metering shall be provided and maintained by KSEB Ltd for the purpose of accounting of the output electrical energy of the plant and the energy injected into the grid/ the energy drawn from the grid. KSEB Ltd shall arrange the meter reading at proper interval. The consumer shall facilitate access to KSEB Ltd staff / its authorised representative for recording monthly/bimonthly meter reading and for taking check reading.

6. Guaranteed Returns

The Consumer shall be eligible to consume 10 % of the gross AC energy output from the plant, free of cost in lieu of providing the rooftop to KSEB Ltd. This 10 % energy eligible for the consumer shall be adjusted in the monthly/ bimonthly consumption of the consumer, as the case may be. If the consumer is not consuming the above eligible energy either partly or fully, the same shall be carried over to the succeeding month and settled at the end of settlement period. For this purpose, the settlement period shall be from October to September.

7. Disputes

Any dispute arising out of this agreement shall be mutually discussed and resolved by the parties within a period of 90 days on having brought such difference or dispute by either party to the attention of the other. Those disputes remaining unresolved will be subject to the exclusive jurisdiction of respective civil courts.

8. Force Majeure Conditions

'An affected Party' means either the Consumer or KSEB Ltd whose performance has been adversely affected by an event of Force Majeure.

A 'Force Majeure' means any event or circumstance or combination of events and circumstances as stated below that wholly or partly prevents or unavoidably delays an Affected Party in the performance of its obligations under this Agreement, but only if and to the extent that such events or circumstances are not within the reasonable control, directly or indirectly, of the Affected Party and could not have been avoided if the Affected Party had taken reasonable care in performing its obligations which consist of

a) Act of God, including, but not limited to lightning, drought, fire and explosion, earthquake, volcanic eruption, landslide, flood, cyclone, typhoon, tornado or Explosion, accident or breakage of transmission/ distribution facilities or

b) any act of war (whether declared or undeclared), invasion, armed conflict or act of foreign enemy, blockade, embargo, revolution, strikes, riot, insurrection, terrorist attack or military action making the performance of obligations as specified herein as impossible.

Force Majeure shall not include

Any event or circumstance which is within the reasonable control of the Parties, ie

- a. Non-performance resulting from normal wear and tear;
- b. The agreement becoming onerous to perform;
- c. Non-performance caused by, or connected with, the Affected Party's;
- d. Negligent or intentional acts, errors or omissions;
- e. Failure to comply with an Indian Law; or
- f. Breach of, or default under this Agreement.

The Affected Party shall give notice to the other Party of any event of Force Majeure as soon as reasonably practicable, but not later than twenty one (21) days from the date of commencement of the event of Force Majeure. If an event of Force Majeure results in a breakdown of communications rendering it impossible to give notice within the applicable time limit specified herein, then the Party claiming Force Majeure shall give such notice as soon as reasonably possible after reinstatement of communications, but not later than seven(7) days after such reinstatement.

Provided that such notice shall be a pre-condition to the Affected Party's entitlement to claim relief under this Agreement. Such notice shall include full particulars of the event of Force Majeure, its effects on the Party claiming relief and the remedial measures proposed.

The Affected Party shall give notice to the other Party of

- (i) The cessation of the relevant event of Force Majeure; and
- (ii) the cessation of the effects of such event of Force Majeure on the performance of its rights or obligations under this Agreement, as soon as practicable after becoming aware of each of these cessations.

9. Lock in period

There shall be a lock in period of five (5) years from the date of commercial operation of the plant during which the Consumer is legally bound to permit KSEB Ltd to keep the plant for its operation and maintenance. However, the Consumer shall have the right to get the agreement terminated and to get plant removed by KSEB Ltd by paying damages to KSEB Ltd as mentioned in Annexure - I of this agreement. If the consumer desires, they may own and operate the plant after payment of amount mentioned in Annexure I.

10. Termination of the Agreement

This agreement shall cease to exist upon the occurrence of the following;

- (i) Termination due to Force Majeure

If the Force Majeure event or its effects continue to be present beyond a period of twelve (12) months, either Party shall have the right to cause termination of the Agreement. In such an event, this Agreement shall get terminated on the date

of such Termination Notice without any further liability to either Party from the date of such termination.

(ii) KSEB Ltd event of default

(a) If KSEB Ltd / its authorised person fails to attend repair / replacement of the defective panels or allied parts for a continuous period of 6 months from the date of intimation of the said request, the consumer shall be at liberty to terminate the Agreement with 30 days notice. In such cases, KSEB Ltd is liable to pay to the consumer the generation loss in actuals.

(b) The Consumer shall be vested with the right to terminate the Agreement if no set off / adjustments have been effected in the monthly/ bimonthly bills for three consecutive settlement periods. In such cases, the Agreement can be terminated by the Consumer with 30 days notice and KSEB Ltd shall be liable to settle the uncounted energy in subsequent bills.

(c) If the plant has not been installed by KSEB Ltd within a period of one year from the date of handing over of the roof top, except due to force - majeure conditions, this Agreement shall be deemed to have been terminated or can continue to mutually agreed extended period.

(iii) If the Consumer is desirous in getting the agreement terminated during the agreement period after the lock-in period of first 5 years.

If the consumer wants to dismantle the plant from his premises during the duration of the agreement period but after the lock-in period of first 5 years, then the consumer shall be liable to pay compensation mentioned in **Annexure - II** of this agreement and KSEB Ltd shall remove the plant. Further if the consumer desires, they may own and operate the plant after payment of amount as mentioned in **Annexure - II**.

(iv) Consumer's event of default

KSEB Ltd shall be at liberty to terminate the agreement with 30 day notice

(a) If the ingress/ egress to the said roof top/premises is restrained by the Consumer continuously for three billing cycles except in cases where prior intimation has been given to KSEB Ltd/ Authorised representative about Consumer's inconvenience to permit access to the said plant.

(b) If the Consumer deliberately tampers with the plant and allied equipments.

(c) If the consumer is not maintaining the space shade-free thereby affecting the generation.

(d) If the Consumer is seen indulging in making alterations/ modifications by himself / engaging a third party, except for cleaning the panels.

(e) If the consumer defaults payment of his/her/their electricity bills and the electricity connection is disconnected / dismantled.

In such events, consumer shall be liable to pay compensation as fixed by KSEB Ltd.

11. Correspondence

(a) Any letter, order or document addressed to the Consumer shall be served by post or e-mail or courier or left at the address given in the preamble to this Agreement in the manner prescribed in Section 171 of the Electricity Act, 2003.

(b) All communication to KSEB Ltd shall be addressed to the State Nodal Officer, Soura Project or to any other officer authorised or designated in this behalf.

12. Notice Period

Both the Parties shall issue notice for a period not less than 30 days for any deviation occurring in the provisions of the agreement.

13. Shifting / Deposit Work Charges

(i) Shifting within the same premises due to factors beyond control of the consumer

If the Solar Plant is required to be shifted within the same premises due to shade affecting the generation from the Solar Plant or due to any other factors which is not within the control or not attributable to the Consumer, the Consumer will identify another space within the premises for shifting the plant. The shifting shall be done by KSEB Ltd at its own cost, one time only during the entire agreement period. If the plant is required to be shifted more than once consumer shall be liable to pay the shifting charges.

(ii) Shifting within the same premises at the instance of the consumer

If the Solar Plant is required to be shifted to a different location within the same premises at the instance of the consumer, the consumer shall be liable to pay the shifting charges, and the shifting work, if feasible shall be arranged by KSEB Ltd within a period of 45 days.

(iii) Shifting to a different premises

If the plant is required to be shifted to a different premises, the Consumer shall be liable to pay the shifting charges, and the shifting work, if feasible shall be arranged by KSEB Ltd within a period of 45 days, after executing new agreement.

14. Transfer of ownership

If the building/ premise where the solar plant installed is sold, the matter shall be intimated to KSEB Ltd within 30 days of the sale. If the same is not done within the stipulated time, the Consumer with whom this Agreement is entered into by KSEB Ltd shall be liable for any compensation to be given to KSEB Ltd for damages/non generation of electricity from the said plant, as the case may be.

Provided that it is the bounden duty of the Consumer/ owner of the building / premises to get it specifically recorded in the sale deed that all the rights and liabilities arising out of the said plant shall be vested with the new owner/ consumer.

15. Plant Outage

If the plant is not generating electricity for a period of more than **48 hours** continuously due to non-availability of grid, other than due to instances of force majeure conditions, compensation shall be payable to the consumer @10 % of the average generation during the corresponding month of previous year. If previous year data is not available, average generation from the plant from date of commencement of generation till the outage date will be considered.

16. Insurance

The insurance for the said plant will be arranged by KSEB Ltd.

17. Completion Period

The period of completion of the installation of the plant shall be six months from the date of handing over the roof top/ premises to KSEB Ltd.

18. Accidents

KSEB Ltd / Solar Power developer engaged by KSEB Ltd shall not be responsible for any accident occurring due to unauthorised access to the plant and associated equipment.

19. Upgradation/Repowering of the Plant

KSEB Ltd shall have the right to re-install the plant for better performance, owing to technological improvements. The consumer shall also be eligible for benefits consequent to enhanced generation from the plant, in such instances.

20. Consumer's Right to opt a different model.

The Consumer shall have the option to changeover to a different model other than the current one, subject to the rules and regulations issued by the Government.

21. Stamp Duty

KSEB Ltd agrees to bear the cost of the stamp duty and all costs incidental to the execution of this agreement in full.

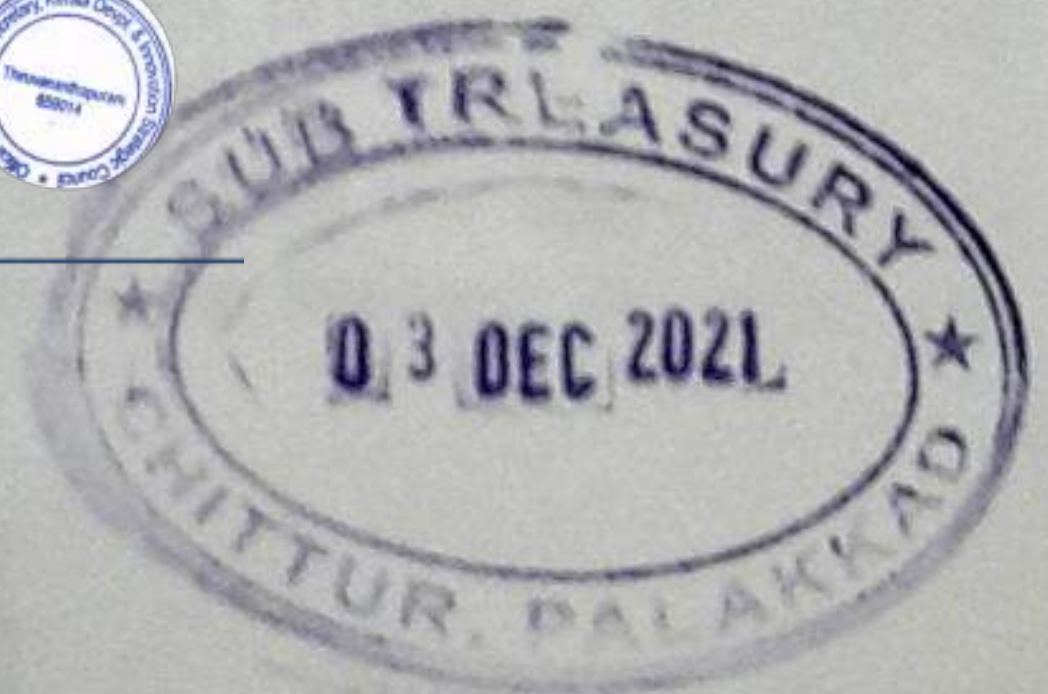

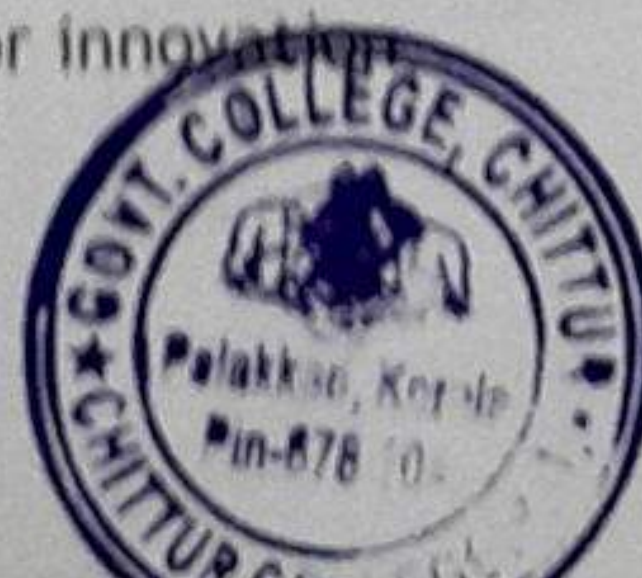

You have confirmed your participation in MTTTS-2023 to be held at IIT Madras during May 22, 2023 to June 17, 2023. Except Sundays, all other days during this period will be working days of the programme. You must reach IIT Madras by the evening of May 21, 2023, and leave IIT Madras on June 18, 2023 morning. If you have not yet booked your train/bus tickets towards these, please do it as soon as possible.

If you are travelling by train, then on arrival at a railway station in Chennai, you can take a bus run by the Metropolitan Transport Corporation, Chennai to reach IIT Madras Main gate. The bus-stops within 400 meters of IITM are Gandhi Madapam bus-stop and Madhya Kailash bus-stop. At IITM gate, please show this letter along with your ID card for entry into the campus. From IITM gate, you can avail a free bus run by IITM to reach hostel. Alternatively, you can take a prepaid auto from the railway station to reach IITM hostel. 
