Our Association was formed in the year 2012 December as " Alumni Association Govt.College Chittur" as initiated by a group of members, which was earlier known as" Old Students Association " . With an executive committee comprising of 25 members, the first full fledged office bearers were elected for two year term. Those were the members who had studied for at least one year in GCC from 1949 onwards. As an organisation registered in the year 2013, we are committed to take responsibilities to see that the deserving students of GCC are getting financial assistance in pursuing their studies. We are thankfully acknowledging the GCC for the co operation we are getting from them. It will not be out of context here , to mention that the College Governing Council has recently allotted us a medium sized hall , to use it as the office of the Alumni Association in GCC Complex. This has helped us to ensure smooth functioning of our Organization and close interaction with GCC Officials.

As on today the membership exceeds 206 and includes Alumni's from 1949 to 2021.The present membership is comprising of 23 Life Members and the rest are ordinary members , from whom yearly subscription amount is levied .Due to the corona context the conduct of AGM and collection of yearly subscription from members became almost impossible.

Meetings and Reviews :-

(a) Executive Committee meetings :- . We have about 150 active core members. We have regular meetings of Executive Committee Members once in three months. Minutes of discussion and decisions taken by the Committee, follow up actions etc are recorded and kept in separate file , available in Office of the Alumni Association. During the meetings decisions are taken after discussion on deliberations and surveys connected with the betterment of college based on upliftment of students of GCC who are financially weak belonging to the working class communities within the periphery of GCC.

(b) Apart from the quarter yearly Executive Committee Meetings , in a need based manner and to meet contingencies if any , Alumni Admin members are required to conduct review meetings as when called for by the President/ Secretary of the Alumni Association. These agenda specific meetings are held to ensure the follow up of decisions taken in Executive Committee Meetings.

(c) Annual General Body Meetings are generally conducted generally in December each year.

Regular Annual General Body Meetings with family get together were conducted in 2014, 2015, 2016, 2018 and 2020. The present set up of Office Bearers were requested to continue for another term by the General Body. .The Annual General Body Meeting of 2022 is proposed to be conducted towards last week of November.

- Treasurer addressed the audience with Annual statement of Accounts and Budget Estimate.A copy of the Annual Accounts statement and Budget Estimates are attached herewith.

- Due to ill health and other personal reasons some of our earlier Executive Committee Members wanted to opt out. Considering those voluntary exits and to inject new energy and vigour to the Committee, a few members were added to the Executive Committee. Keeping in view an optimum strength of 25 Members to the Committee, the new list was adopted for consideration. The list of Executive Members are attached herewith.
- An exhibition cum sale of Books written by Several GCCians was on display at the venue of AGM on 26.12.2022.
- A poem as written by Mr.N.K.Venkateswaran descriptive of the Glory and Sanctity of Sokanashini river and it's relevance to GCCians was distributed to member participants of AGM.A copy of the poem enclosed.
- Mr.A.V.Narayankutty , the Vice President of GCC - AA gave vote of thanks to one and all for making the occassion gracious through their presence during the proceedings of AGM .
- The AGM was concluded at around 2 PM and a lunch was hosted to all the Member Participants, Guests and the Students also who received the awards and scholarships.

SECRETARY'S REPORT

First of all, I thank you all for coming over here to attend this Alumni General Body Meeting. It is with great pleasure that I welcome you all for this function .It is actually a get together of various ages which itself show the strength of the Association. Our members are hailing from the period 1948 to 2020. The bond between us is one Base, i.e. we have all studied in this great Institution G.C.C.

The Association has taken shape from the G.C.C. old students Association in December 2012. A team of 25 E.C.Members with a new set of Office Bearers took over in 2012.Our Association was registered in October 2013. After wards we are working for the well being of the college and students through involvement in various activities. Due to age related problems all the E.C. Members could not take part in all the activities. Hence this time a fresh change is made in the E.C. to accommodate new members, who can actively participate in the activities.

With regard to the meetings our Executive Committee is meeting every 03 months and admin group meeting every 30 days to review the activities. From last March onwards our Meetings are held in the office room allotted to us by the college authorities. For this we are indebted to many in the College Administration, as their backing has resulted in getting this office room.

I will just briefly go through our activities during the last year 03 years. Last AGM was held in December 2019. Due to Corona restriction further get together was not possible in 2020 and 2021.

Our Flagship Program "CHIRAKU" is getting wide attention. Already from the academic year 2017- 18 to the present academic year of 2022-2023 , we have helped in all a total number of 36 Students for Covering the expenses connected with the studies of their Degree Course . The cumulative financial assistance provided by the Association through "CHIRAKU" now stands at Rs 13.86 Lakhs. We thank all the Sponsors as well as all the Donors, as their generous help has been instrumental in helping the deserving Students. We hope to receive more help in future too from all alumnis in augmenting this Programme.

During Corona period we have helped students to buy mobile phones.

Also we have helped needy Sports Students to buy sports equipments for their training. During the peak of Corona our members have contributed by handing over 50 Face Shields to the staff of Chittur Police Station.

Apart from this the issuance of year end scholarships to various students of excellence in Studies, Sports, Arts and other activities are going on. In this regard we are pleased to thank Proff. Alum Moottil Michael, Smt.Latha Varma, Economics Batch of Mr.Sheshadri , Prof Jayadevan for NSS Volunteers . Their continued contributions have resulted in giving away of excellence awards from 2017 onwards and upto this year as summed up below: -

- 1) The total number of students who have benefited from this scheme of "issue of excellence awards" now stands at 72 students.
- 2) The total amount disbursed through this scheme from 2017 onwards and upto this year is Rs. 2.75 lakhs

The Alumni Park and Vanajam Stage donated by us to the college is being utilised by the students in many of their occassions.

75 th Year "Platinum Jubilee" is being celebrated by College and Alumni Association has actively participated in all programs. On 6th March while participating in "Gruhathuram" we have honoured our old faculties of GCC. We have contributed a sizable sum through members of our Association for the construction of homeless students of GCC.

Our participation in the NAACC related certification process cum ranking has helped the College during their last visit. We are hopeful of having another round of fruitful participation this year too for functional preparedness in getting through the accreditation.

Mamangam season 02, the largest gathering of our Association's members was held on ___19th June 2022_____. The members from FB groups and Admin Groups of our Association has jointly made it a grand success. Entertainment was galore , coupled with a Book fest and art exhibition etc . Our team work at tandem with alumini FB admins in all our activities and there support is highly acknowledged

Last but not the least, the appeals made by various members of Alumni Association through FB groups and various WhatsApp groups were instrumental in raising necessary funds for helping students through "CHIRAKU" . We will therefore request you all to be generous in contributing to the cause of uplifting the financially backward students, through "CHIRAKU". Thank you once again, for your kind cooperation and much valued participation in "CHIRAKU" programme.

Futuristic Programmes of AA-GCC.

Conducting of :-

- 1) Seminars with themes of promoting inspirational and motivational behavioral patterns amongst students
- 2) Workshops for spreading awareness and inculcating preparedness and readiness about the future course of activities for job hunting.
- 3) From the experiences we had met with, the students who are hailing from financially weakest family background suffered hardships like:-

- 1) Sometimes they don't have money to net recharge.
- 2) Unable to attend interviews, when called for by prospective employers.
- 3) Sometimes suffering from serious illness

In such circumstances to help the truly deserving students, we should generate a special "Students Aid Fund" This idea was mooted by our president Professor K. Jayadevan in one of the Executive Committee Meetings.

- 4) Giving training and Faculty programmes
- 5) Conducting of events like Music Concert etc., aimed at Fund Raising for Charity purposes.
- 6) Web designing with portals and windows to promote liasoning with prospective donors and sponsors.
- 7) To assist the Principal of GCC in infrastructural development of college
- 8) Giving "certificate of participation" to the attendees of various Faculty programmes, Trainings and workshops etc in a case by case manner, which will add value to the Bio-Data of the students.

Our alma mater, Government College Chittur, (GCC) has played a significant role in our cultural, social and educational development- in fact, responsible for **Where We are in our Life today.**

Alumni Association Government College Chittur has great pleasure in cordially inviting you to our fold to be part of a group which is emotionally attached to the institution for its overall development and be a helping hand for deserving students from the socially and economically weaker sections of the society.

Prelude:

A group of old students of first decade of College's existence, 1950's, used to meet, exchange ideas and reminisce about their days in GCC. The Saga began there. A few years later they found it difficult to continue with their association on account of age and health conditions. One of them contacted **Prof. Jayadevan**, an alumnus and ex-faculty of the college to explore whether he could take the initiative forward. Our illustrious and enthusiastic President, Prof. Jayadevan showed his inclination to carry the tradition and ethos forward.

Mr. A V Haridas as President and Prof. Jayadevan as Secretary had a humble beginning of the association in 2012. Alumni Association, Government College Chittur was registered in 2013 NO: PKD/TC/84/2013 with Prof Jayadevan as President and Mr. Rabindranath N Menon as Secretary. Since then, the Association has been in the forefront of welfare activities for students and act as a support system for College Administration

Objectives:

- Sponsorship of students under "**CHIRAKU**" scheme.
- Scholarships to students for excellence in academic and extra-curricular activities.
- Support system for infrastructure development of the institution.
- Seminars, Workshops, Training and Faculty programmes.
- Sponsored events and Fund-raising programmes for Charity.
- Liaison, Net- working and Entertainment for Alumni.

Accomplishments:

"CHIRAKU "CARING COMPASSIONATE CONSIDERATE": Chiraku is the signature charity programme of the Association that supports eligible students from economically backward background during their college life with a financial assistance of Rs.14,000/- per year for three years. The initiative had its humble beginning in 2017-18. After an initial vetting of students by the college administration, the screening committee of the Association conducts further enquiries before selection of the final list to ensure that only deserving candidates

enjoy the benefit. And it is an ongoing evaluation process as to their annual academic performance and other parameters till the course is completed.

The scheme has so far spent Rs.13.86 lakhs and is committed to support 35 students with a future commitment of Rs.5.46 lakhs.

Chiraku is one of the most noble deeds of the Association and satisfying and enriching experience for the members.

Scholarships: A number of Endowment scholarships are awarded every year for excellence in academics and co-curricular activities. Since 2016-17 we have distributed Rs.2.64 lakhs so far on 68 students.

Vanajam: An Open-Air stage and Alumni Park was constructed and handed over to the College in 2017. A totally tiled area of 4400 sq. ft. was at a cost of Rs. 7 lakhs approx.

Funds Mobilisation:

Mobilisation of funds have been from a very modest base of well-wishers so far. The sources of finances have been:

- Annual membership of Rs.500/-
- Life membership of Rs.5,000/-
- Sponsorship for "Chiraku" Rs.14,000/- per annum for 3 years.
- Donations in Cash and Kind from individuals and Groups.

The current membership is very few for a college that is celebrating its Platinum Jubilee. Our endeavour is to widen the activities of the Association on a broader scale. We would urge all of you to extend maximum help to the Association in whatever manner possible-financially or physically in furthering the good work of the Association.

Team:

It is a 25 members Executive Committee elected for a period of Two years by General Body. The present committee was elected on 26/12/2022. We operate from an Office space in the College campus allotted by the College Administration.

Annual General Meeting will be in December every year.

" CHIRAK " Award of Scholarships: - Scholarships are awarded to eligible students, studying in GCC who are hailing from the vicinity of GCC , including two or three from among hostel dwellers also , who are financially very backward . These students are hand picked after doing a field survey by a team lead by the President and Secretary of the Alumni Association.

As far as Scholarships of year 2021-2022 are concerned, based on a list of 50 students provided by the teaching fraternity of GCC , all the Students were telephonically interviewed and short listed to 20 students as eligible , by applying certain parameters of merits and economic backwardness. Considering the Funds available for Distribution , we had to limit the numbers to 13 students for this academic year , whose names , family background and photographs (which are strictly confidential) are as shown in this briefing. This year the Scholarship Distribution was done on 6th March 2022 at MG hall of GCC , in a programme chalked out as Grihathuram . forming part of Platinum Jubilee Celebrations of GCC.

The history of numbers of students benefitted by Scholarship each year is as noted below:-

- 2015- 2016 = 3 students
- 2016- 2017 = 7 students
- 2017- 2018 = 12 students
- 2018-2019 = 13 students
- 2019-2020 = 15 students
- 2020-2021 = 09 students
- 2021-2022 = 13 students
- 2022-23 = 10 Students

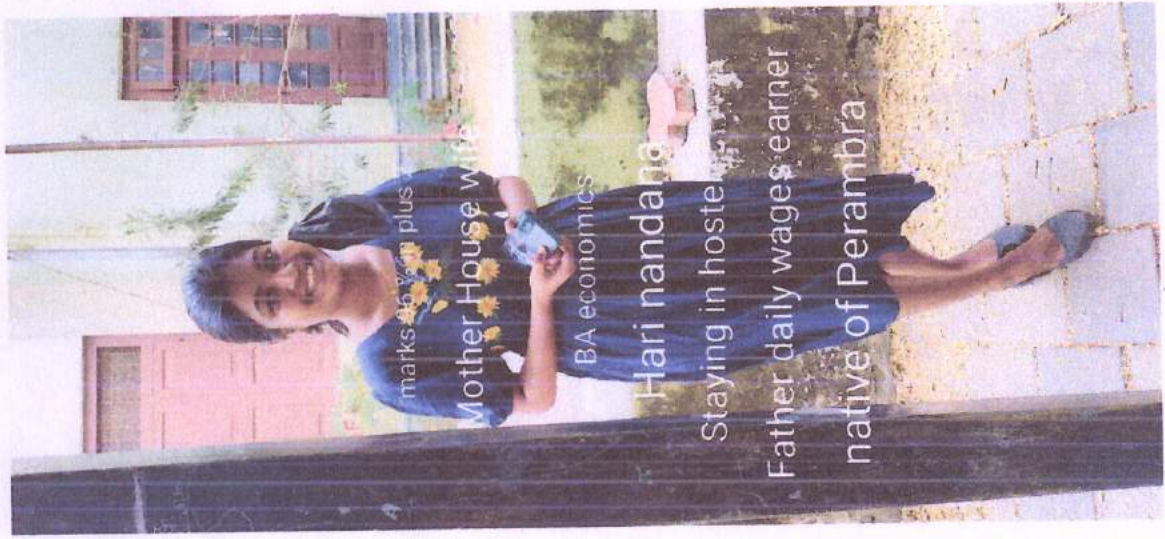

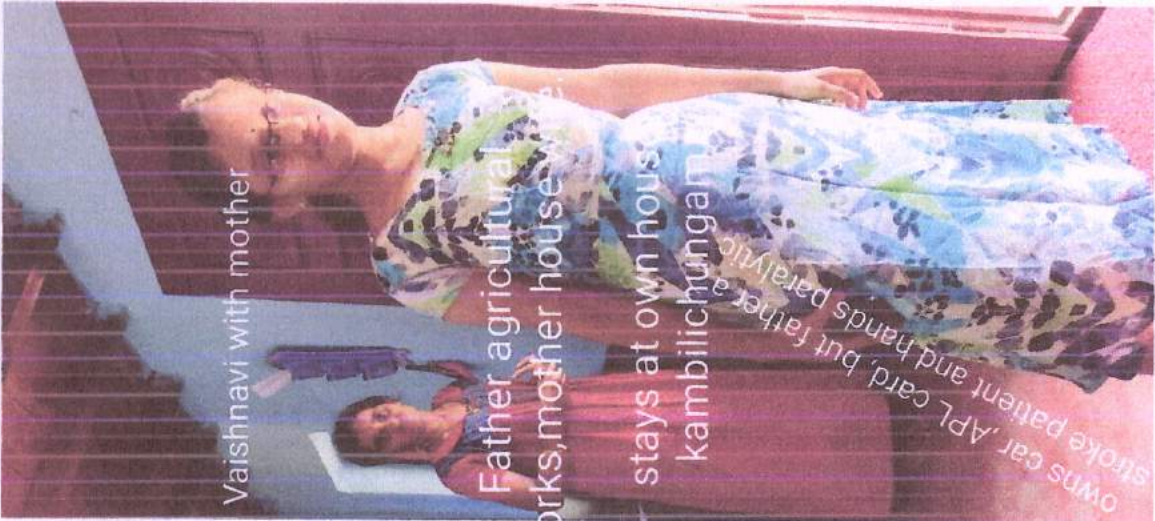

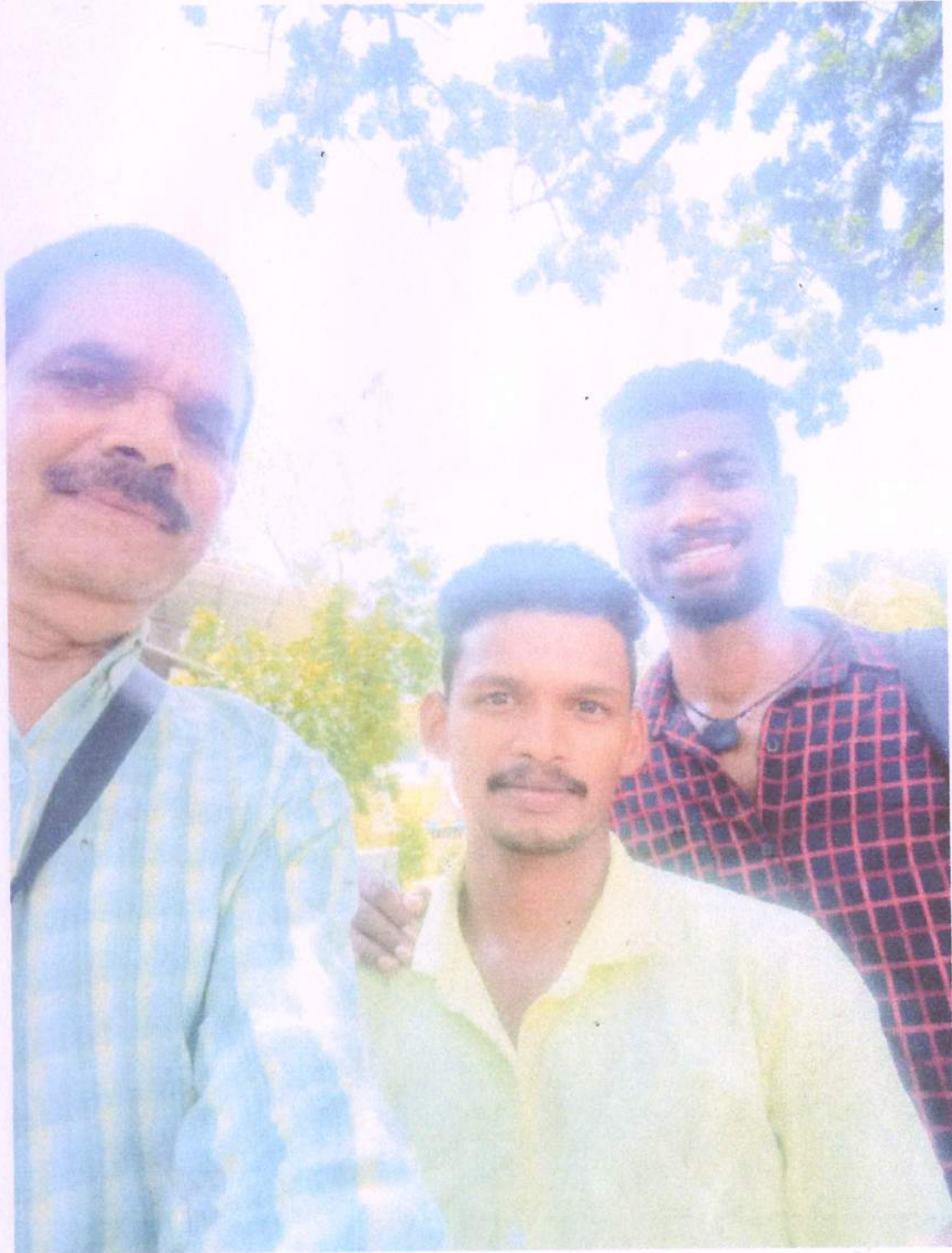
- providing of anti corona protective gears like Face Shields to 50 Policemen of the Chittur Taluk Police Station

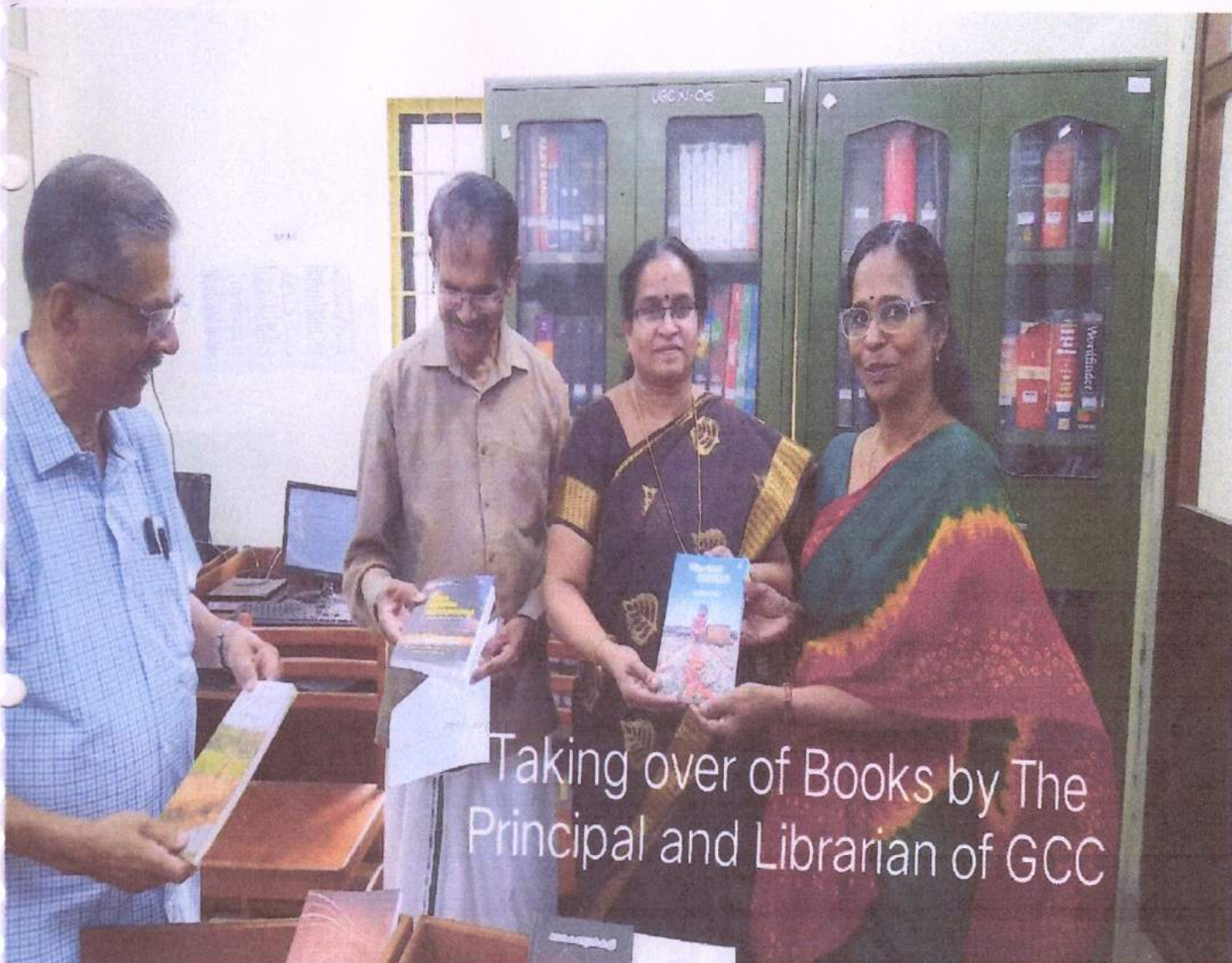

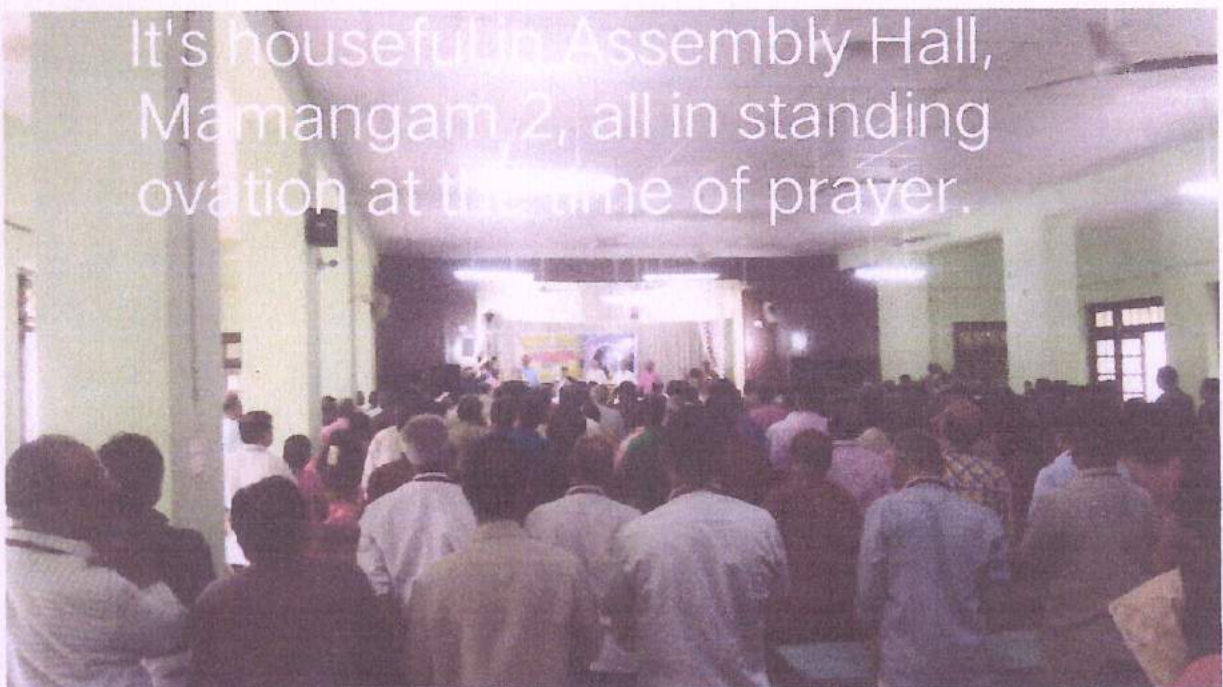

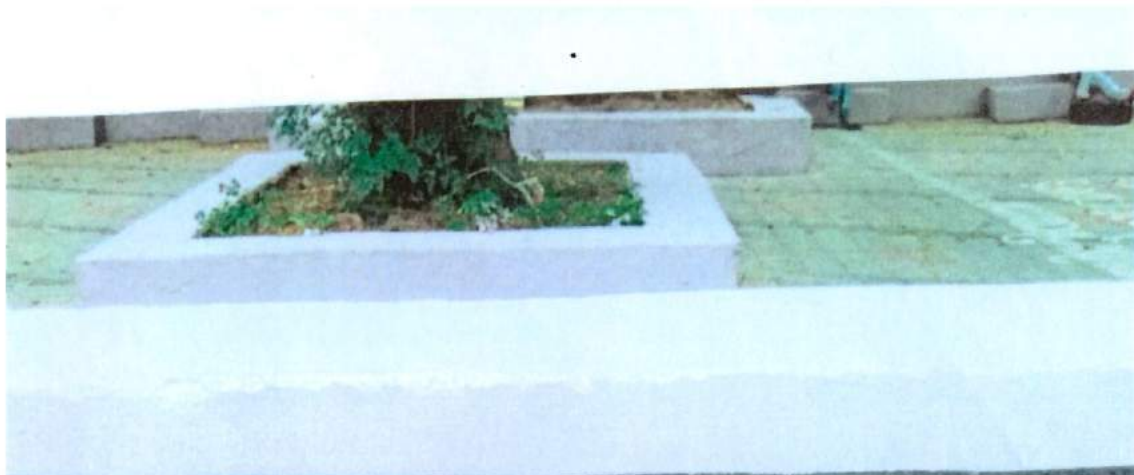

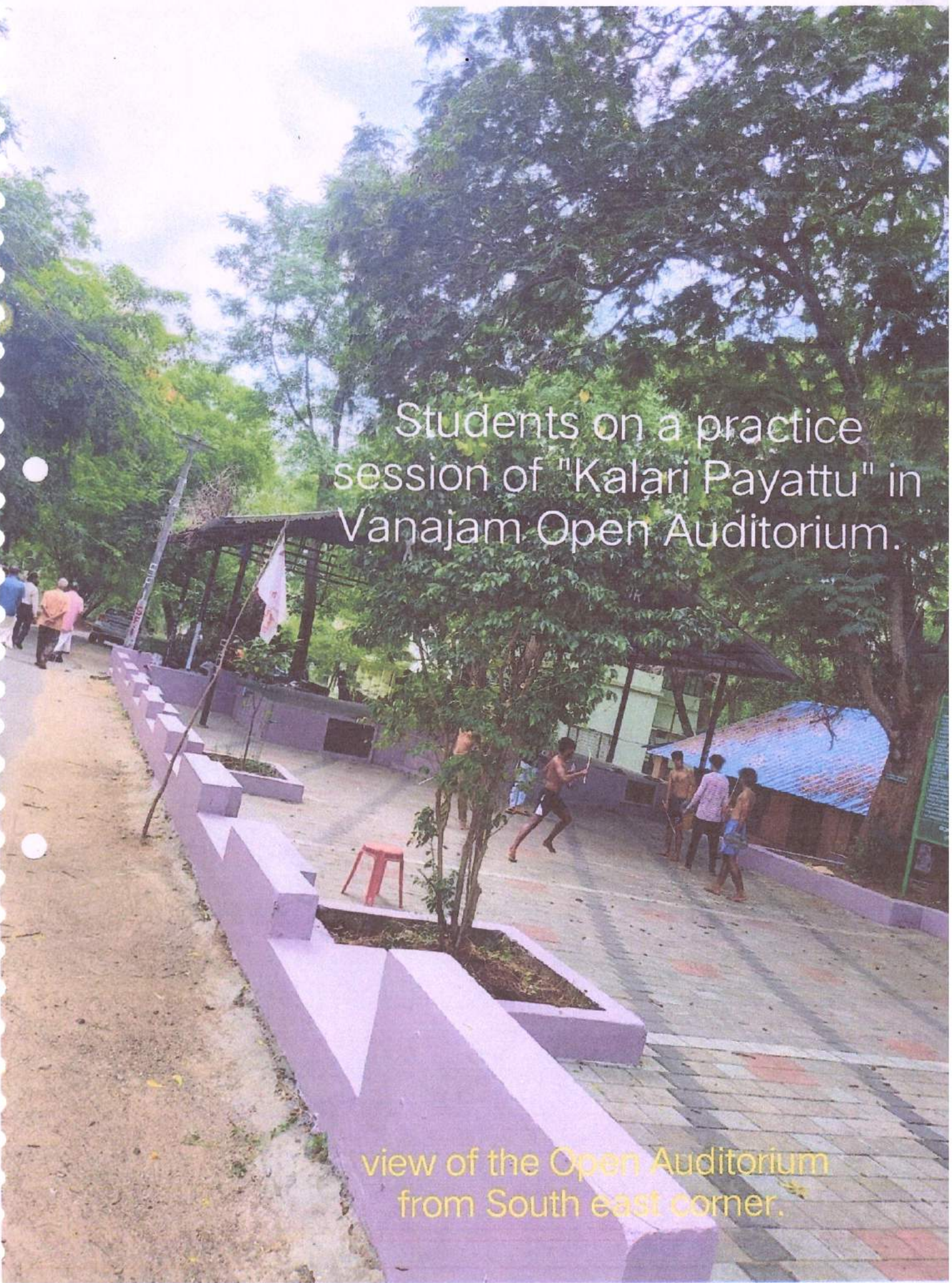

1. MEMBERSHIP

Every past students of the college shall be eligible to be

- a) A member on payment to the association an annual subscription of Rs.500/-
- b) A life member on payment of Rs. 5000/- - Five Thousand only.

2. COMMITTEE

Executive Committee of the Association and office bearers are decided by the General Body. The present number of E.C. members are 25+1 co-opted.

3. MODE OF SELECTING OFFICE BEARERS

By election in the General Body for a two year term.

4. BOARD OF OFFICIALS

President, Vice President, Secretary, Joint Secretary, Treasurer, Principal of the college shall be Special Invitee. The immediate past president and secretary shall be Ex-officio members.

5. TERMINATION OF OFFICIAL POSTS

As decided upon in the General Body meeting

6. QUARROM

For General meeting $1/10^{\text{th}}$ of the total number of members of association, rounded off to the nearest whole number, personally present shall form the quorum of the meeting.

7. MEETING ACTIVITIES

Annual General Body to be held once in a year in the month of April.
Executive committee should meet in 3 months.

8. ANNUAL GENERAL BODY

Once in a year in April

9. RESPONSIBILITIES OF OFFICIALS

PRESIDENT

All meetings to be presided over by the President. President is responsible for overall administration of the association and any other work assigned to by the EC or General Body.

VICE PRESIDENT

In the absence of the President the Vice President preside over the meeting of the General Body or shall assign by the President in all discharge of duties / responsibilities.

SECRETARY

The Secretary, subject to the general supervision, guidance and control of executive committee shall :

- a) Be primarily responsible for the administration of the association and for the implementation of its projects.
- b) Be the custodian of all movable and immovable properties of the association and he shall maintain an Asset Register of the association.
- c) Call meeting of Executive Committee and General Body. Prepare and present the minutes of the meeting there of at the next meeting for being confirmed and taken on record.
- d) Carry on all correspondence on behalf of association. Maintain all records send notice of meetings and attend to all business of the association and serve for carrying out all resolutions.
- e) Maintain accounts of all monies received and spent in the course of management of the association properly.
- f) Take all such lawful acts as he may deem necessary and expedient for the attainment of the objects of the association.
- g) Arrange to make over to the Treasurer all cash, cheques, DDs etc received on behalf of the association.
- h) The secretary shall keep recoupable permanent advance of Rs. 1000/- from the General funds of the association for the expenditure on postage, stationary and other contingencies.

JOINT SECRETARY

In the event of the vacancy of the post of Secretary, the JT Secretary shall act as the Secretary and do all duties and powers of the Secretary until a new Secretary assumes office.

TREASURER

- a) The Treasurer shall be responsible for the safe custody of the association funds. He shall keep the passbook, cheque books in his custody and produce them before the Executive Committee as and when required. The Treasures shall take charge of all cash, cheques, DDs made over to him by the Secretary of any other office bearer and arrange properly to deposit them in the bank account of the association.
- b) Shall maintain correct accounts of income and expenditure of the association and such accounts and vouchers shall be submitted to the Executive Committee at every meeting for approval.
- c) For withdrawal of funds Secretary or President and Treasurer shall jointly sign the cheque.
- d) It is the duty of Treasurer to render accounts to the Executive Committee and General Body, Shouldn't mix up private cash with association funds.
- e) The Secretary and Treasurer and Joint Secretary shall be competent to receive subscription, donations, and all other monies on behalf of the association and issue receipt for the same.

The accounts of the association shall be audited annually by a Chartered Accountant appointed by the Executive Committee and audited financial statements counter signed by the Secretary and Treasurer shall be submitted to the committee within such time as it may direct. No member of the Executive Committee shall be competent to be appointed as auditor.

10. AMENDMENT TO BYLAWS

Only by the approval of General Body amendments can be made.

11. FILING OF ANNUAL RETURNS

Every year audited returns should be submitted to the authorities and produced before the General Body for approval. Due to any reasons the working of the association stops/terminates, the assets of the association will be deputed with the government or any other similar association on any other reasons the same will not be distributed among the members of the association. We affirm to the above pledge. This is a copy of Bylaws approved by our first General Body meeting held on 22/12/2012.

12. True copies of the list of newly elected Executive Committee, copy of statement of income and expenditure duly approved by the General Body, copy of the Balance Sheet, all counter signed by three members of the Executive Committee shall be submitted to the Registrar of Societies within 14 days from the date of General Body Meeting.

13. Amendment of Bye-laws

The Executive Committee decided to amend the bye laws, a written resolution shall be circulated among the members of the General Body with clear 10 days notice. Amendments

shall be made either in the annual General Body meeting or a special General Body meeting convened for the purpose. After passing the amendments by the General Body by 3/5th voting and a subsequent General Body shall be convened after the gap of one month and pass the amendments by 3/5th votes by the members present before effecting the amendments. A copy of the amendment shall be submitted to Registrar of Societies within 14 days, duly attested by not less 3 members of the Executive Committee..
